ORDINANCE NO. 2305

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE VILLAGE OF RANTOUL, CHAMPAIGN COUNTY, ILLINOIS (INGLEMAN/KIRCHER TRACT)

WHEREAS, a written Petition for Annexation dated June ___, 2012 and signed by Milton Bryan Ingleman, As Successor Trustee Of The Milton R. Ingleman Living Trust Agreement Dated May 8, 1985, And Steven A. Kircher, As Trustee Of The Beth Alena Kircher Revocable Declaration Of Trust Dated July 12, 2007, as owners (collectively, the "Owner"), the legal owners of record of all real estate within the territory hereinafter described, has been filed with the Village Clerk of the Village of Rantoul, Champaign County, Illinois, (the "Village") requesting that such territory be annexed to the Village; and

WHEREAS, there are no electors residing within such territory; and

WHEREAS, such territory is not within the corporate limits of any municipality but is contiguous to the Village; and

WHEREAS, legal notices regarding the intention of the Village to annex such territory have been sent to all public bodies required to receive such notice under the laws of the State of Illinois, it having been determined that such territory to be annexed is not a part of any Fire Protection District or any Public Library District and does not include a highway under the jurisdiction of Rantoul Township; and

WHEREAS, copies of such notices required to be recorded, if any, have been recorded in the Office of the Recorder of Deeds of Champaign County, Illinois; and

WHEREAS, all petitions, documents, and other necessary legal requirements are in full compliance with the laws of the State of Illinois, including in particular Section 7-1-8 of the Illinois Municipal Code (65 ILCS 5/7-1-8); and

WHEREAS, it is in the best interests of the Village that such territory be annexed to the Village.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RANTOUL, CHAMPAIGN COUNTY, ILLINOIS, as follows:

Section 1. That the following described territory:

(See Plat of Annexation attached hereto and made a part hereof),

together with any adjacent highway or part thereof to the far side of any such highway is hereby annexed to the Village of Rantoul, Champaign County, Illinois.

<u>Section 2</u>. That the Village Clerk is hereby directed to record with the Recorder of Champaign County, Illinois and to file with the County Clerk of Champaign County, Illinois, a certified copy of this Ordinance, together with an accurate map of the territory annexed.

<u>Section 3</u>. That the Village Clerk is hereby further directed to send by registered or certified mail a copy of this Ordinance to the post office branch serving such territory and to send by regular mail a copy of this Ordinance to the County Administrator of Champaign County, Illinois and to the Township Commissioner of Highways and the Board of Township Trustees of Rantoul Township, Illinois.

Section 4. That this Ordinance shall be in full force and effect from and after its passage and approval as provided by law.

This Ordinance is hereby passed, the "ayes" and "nays" being called, by the roll call vote of the members of the Corporate Authorities at a special meeting on the date set forth below, as follows:
