

ORDINANCE NO. 2022

AN ORDINANCE OF THE VILLAGE OF RANTOUL, CHAMPAIGN COUNTY, ILLINOIS TO WITHDRAW AS A MEMBER OF THE ILLINOIS MUNICIPAL GAS AGENCY AND AUTHORIZING THE EXECUTION OF A NOTICE TO WITHDRAW

WHEREAS, the Village of Rantoul, Champaign County, Illinois (the “Village”) is a municipality owning and operating a natural gas utility system, which furnishes retail natural gas service to the public; and

WHEREAS, the Village is presently a member of the Illinois Municipal Gas Agency, which was formed pursuant to the provisions of the Illinois Joint Municipal Natural Gas Act, contained at Division 119.2 of Article 11 of the Illinois Municipal Code, as amended (the “Act”); and

WHEREAS, the Village, by this Ordinance, hereby finds and determines that it is in the best interests of the Village to withdraw as a Member of the Illinois Municipal Gas Agency;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RANTOUL, CHAMPAIGN COUNTY, ILLINOIS, as follows:


Section 1. The findings and determinations set forth in the preambles to this Ordinance are hereby made findings and determinations of the Village and incorporated into the text of this Ordinance by this reference.

Section 2. The Village President of the Village is hereby authorized and execute and the Village Clerk of the Village is hereby directed to attest, pursuant to this Ordinance, the Notice to Withdraw, substantially in the form of Exhibit 1 attached hereto, and to serve such notice upon the Illinois Municipal Gas Agency.

Section 3. That this Ordinance shall be in full force and effect from and after its passage and approval as provided by law.

This ordinance is hereby passed, the “ayes” and “nays” being called, by the concurrence of a majority of the members of the Corporate Authorities then holding office at a regular meeting on the date set forth below.




