AN ORDINANCE

TO APPROVE THE WITHDRAWAL OF THE

THE ILLINOIS MUNICIPAL GAS AGENCY

WHEREAS, the Village of Rantoul, Champaign County, Illinois, is a member of the Illinois Municipal Gas Agency; and

WHEREAS, the City of Bushnell, McDonough County, Illinois, Cairo Public Utility Company, Inc., Alexander County, Illinois, City of Casey, Clark County, Illinois, Village of Edinburg, Christian County, Illinois, City of Flora, Clay County, Illinois, City of Marshall, Clark County, Illinois, City of Martinsville, Clark County, Illinois, City of McLeansboro, Hamilton County, Illinois, Village of Rantoul, Champaign County, Illinois, City of Red Bud, Randolph County, Illinois, City of Roodhouse, Greene County, Illinois, Village of Stonington, Christian County, Illinois, City of Sullivan, Moultrie County, Illinois, and City of Waterloo, Monroe County, Illinois desire to withdraw as members of the Illinois Municipal Gas Agency; and

WHEREAS, the City of Bushnell, McDonough County, Illinois, Cairo Public Utility Company, Inc., Alexander County, Illinois, City of Casey, Clark County, Illinois, Village of Edinburg, Christian County, Illinois, City of Flora, Clay County, Illinois, City of Marshall, Clark County, Illinois, City of Martinsville, Clark County, Illinois, City of McLeansboro, Hamilton County, Illinois, Village of Rantoul, Champaign County, Illinois, City of Red Bud, Randolph County, Illinois, City of Roodhouse, Greene County, Illinois, Village of Stonington, Christian County, Illinois, City of Sullivan, Moultrie County, Illinois, and City of Waterloo, Monroe County, Illinois have complied with all conditions for withdrawal of membership; and

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RANTOUL, CHAMPAIGN COUNTY, ILLINOIS, as follows:

Section 1. The findings and determinations set forth in the preamble to this Ordinance are hereby made findings and determinations of the President and Board of Trustees of the Village of Rantoul and incorporated into the text of this Ordinance by this reference.

Section 2. The City of Bushnell, McDonough County, Illinois, Cairo Public Utility Company, Inc., Alexander County, Illinois, City of Casey, Clark County, Illinois, Village of Edinburg, Christian County, Illinois, City of Flora, Clay County, Illinois, City of Marshall, Clark County, Illinois, City of Martinsville, Clark County, Illinois, City of McLeansboro, Hamilton County, Illinois, Village of Rantoul, Champaign County, Illinois, City of Red Bud, Randolph County, Illinois, City of Roodhouse, Greene County, Illinois, Village of Stonington, Christian County, Illinois, City of Sullivan, Moultrie County, Illinois, and City of Waterloo, Monroe County, Illinois desire to withdraw as members of the Illinois Municipal Gas Agency.

Section 3. This Ordinance shall be in full force and effect from and after its passage.


