**ORDINANCE NO. 2720**

**AN ORDINANCE REAPPORTIONING  
THE VILLAGE OF RANTOUL'S VILLAGE BOARD DISTRICTS**

**WHEREAS**, Ordinance 2649 was adopted by the Village Board on June 9, 2020 approving a map which established the boundaries for the initial districts for election of Trustees by district; and,

**WHEREAS**, pursuant to Section 3.1-25-75 of the Illinois Municipal Code (65 ILCS 5/3.1-25-75) (the "Act"), the Village shall redistrict whenever necessary after establishing the initial districts; and,

**WHEREAS**, a decennial census may show population shifts within the Village districts which would require reapportioning the districts in order to maintain districts of substantially equal population; and,

**WHEREAS**, the 2020 decennial census results showed shifts in population such that no all districts of the Village were of substantially equal population; and,

**WHEREAS**, the 2020 decennial census results require the Village to reapportion certain districts in order to provide that such districts are of substantially equal population; and,

**WHEREAS**, the Village conducted three public gatherings, and invited public comment and input on reapportioning the districts;

**WHEREAS**, the public input and comments resulted in the creation of a map which reapportions the districts, whereby each district is of substantially equal population; and,

**WHEREAS**, there has been presented and there is now before the meeting of the President and Board of Trustees of the Village (the "**Corporate Authorities**") at which this Ordinance is considered a proposed map which reapportions the Village's six (6) districts (the "**Map**"), a copy of which is also attached hereto and made a part of this Ordinance.

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RANTOUL, CHAMPAIGN COUNTY, ILLINOIS**, as follows:

**Section 1. Findings.** The Corporate Authorities hereby find, determine and declare as follows: (i) that the matters hereinabove set forth in the preambles and recitals to this Ordinance are true, correct and complete and are hereby incorporated herein by this reference thereto; and (ii) that the Map attached hereto and made a part hereof reapportions certain districts which are compact, contiguous, and of approximately equal population.


**Section 2. Adoption of Map.** The Corporate Authorities hereby adopt the Map, marked Exhibit A, attached hereto and incorporated by reference herein, as the official map setting forth the boundaries of the six (6) Village Board districts for the Village of Rantoul.

**Section 3. Electors.** Beginning with the next succeeding election of Village officers held in accordance with the general election law, each of the districts established by the Map shall be represented by one trustee in accordance with the Act.

**Section 4. Publication.** The Village Clerk is hereby authorized and directed to cause this Ordinance to be published in pamphlet form.

This Ordinance is hereby passed, the “ayes” and “nays” being called, by a majority of the Corporate Authorities then holding office at a regular meeting on the date set forth below.


